RESOLUTION OF THE CITY OF VALLEY GRANDE

WHEREAS, the City of Valley Grande is applying for a Community Development Block Grant from the Alabama Department of Economic and Community Affairs to rehabilitate sewer lines; and,

WHEREAS, the City of Valley Grande recognizes the need for the rehabilitation of the lines; and

WHEREAS, the City of Valley Grande wishes to apply for \$450,000 in CDBG funds and commits \$45,000 cash towards a total project of \$495,000;

BE IT THEREFORE RESOLVED, the City of Valley Grande, adopts this resolution committing match and authorizes Mayor Wayne Labbe to sign the application and all pertinent paperwork.

ADOPTED, this the 18th day of May 2015.

Mayor Labbe declared Resolution 2015-38 adopted.

Mayor's Report:

Mayor Labbe reported that he has met with the EDA regarding the International Pilot training facility is still considering Selma as a location. The decision should be made within the next couple of months. It could have between 600 and 700 employees. He expects an increase in residential building in the Valley Grande area and is hoping it will increase the chance of getting the Highway widened through Valley Grande.

Mayor Labbe stated that Saturday will be the Championship Saturday at the Sports complex. He asked that any council members that could help to please be at the complex by 8:30 am. The City will be feeding the players and their families. He further stated that to date a total of 5,423.00 has been collected for admission fees and concessions.

Mayor Labbe reported a sewer line from the bathroom to the septic tank has broken. It is covered right now and will have to be repaired after baseball season.

Mayor Labbe reported that he met with Coach Moore regarding the softball team from Dallas County High School playing their home games at the Sports Complex. They will be meeting again within the next couple of weeks. He stated that high school would collect the admissions but the City would collect the concessions during these games.

There being no further business to come before the council, a motion to adjourn was made by Donna Downs. Ronnie Sawyer made the second. The motion was carried by unanimous consent of the council members present.
