# **Reports of Officers:**

<u>Boyd Pugh /Public Safety Director:</u> Boyd Pugh reported 14 fire calls during the month of May. He also reported a break in the sewer line that discharged to Valley Creek during Memorial Day Weekend. North Dallas Water Company had the equipment needed and made the repairs for us. There was also a leak in the line at the Nitrate tower and a pump that needed repairing. Plumbing Contractors and EMC were able to make the repairs

<u>Sam Smitherman/Building Inspector</u>: Sam Smitherman reported 6 houses currently in construction.

<u>Tim White /Zoning, Annexation and Sewer System:</u> No report.

Ronald Sawyer / Beautification and Education: Ronnie Sawyer asked that we hire someone to pick up a mattress and trash that had been dropped on Highway 22. All council members agreed.

<u>Lamar Morgan / Public Safety:</u> Lamar Morgan reported he has spoken with Boyd regarding lights for the flag poles. He and Boyd are going to get a plan and an electrician to advise them.

<u>Tammy Troha / Parks and Recreation:</u> Tammy Troha stated there everything is on target for the fourth of July. Paul Alexander will be providing the music to go along with the fireworks. She also stated that she would like to have the Christmas beauty pageant winners present at the July 4<sup>th</sup> celebration. Tammy further reported that the Farmer's Market has started and we hope to have more vendors in the future.

<u>Jimmy Johnson / Business and Community Development:</u> Jimmy Johnson reported that he and Matt met with David Oliver. Mr. Oliver informed them that he has an Engineer and Contractor lined up for the project. He has given the contract to his attorney to review and will report back to them.

<u>New Business:</u> Chris Neuenschwander, CPA with Jackson Thornton accounting firm presented the council with the audited financial statements for the year ending September 30, 2017. He reviewed each statement with the council and reported that the City is in very good financial standing with and unrestricted net position of \$747,417.

Lamar Morgan stated that he is to meet with the Electrician regarding the lights on the flag pole. He also stated that he would like to have the electrician regarding underground power at the Walking Trail. Lamar also stated that he would like to talk to Selma Communications about the cost of having the cameras installed at the walking trail only, according to the video surveillance system that was previously bid.
