RESOLUTION 2016-68

RESOLUTION OF THE CITY OF VALLEY GRANDE FORMAL AMENDMENT#1 (LR-CM-PF-15-013)

WHEREAS, the City of Valley Grande has received Community Development Block Grant (CDBG) funds for sewer rehabilitation in the Overlook Hills Subdivision to perform CCTV inspection, manhole rehabilitation, and CIPP lining in sewer mains;

WHEREAS, there are unobligated construction funds due to favorable bid prices;

WHEREAS, during the CCTV process it was found that two of the sewer lines in the subdivision had collapsed and will need to be replaced;

WHEREAS, the city must replace these lines in order to provide effective sewage disposal for the residents in Overlook Hills;

NOW THEREFORE BE IT RESOLVED, that the City of Valley Grande adopts a formal amendment to its CDBG grant # LR-CM-PF-15-013. This amendment will add replacement of the two sewer lines to the scope of the CDBG sewer rehabilitation project.

Tammy Troha recommended the council consider biding out the concessions at the Sports Complex and hire a high school student at minimum wage to take up the gate money. After discussion, the council aske Tammy to come up with a minimum bid amount for the concessions and make a recommendation to the council.
