RESOLUTION 2016-48

RESOLUTION TO AMEND SECTION 6 OF THE SUBDIVISION REGULATIONS

IN THE CITY OF VALLEY GRANDE

WHEREAS, The City of Valley Grande has the authority to regulate the creation of subdivisions; and

WHEREAS, it is the purpose of the City of Valley Grande to promote the health, safety, convenience, order, prosperity, and general welfare of their residents: AND

WHEREAS, Ordinance 2015-39, AN ORDINANCE TO REGULATE THE CREATION OF SUBDIVISIONS IN THE CITY OF VALLEY GRANDE, Section 8 states that the adoption of any amendment to these subdivision regulations shall be by resolution of the City Council carried by the affirmative votes of a majority of the members of the council,

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Valley Grande, that Section 6.5 be added to Ordinance 2015-39 as follows:

6.5 Size and Shape of Lots

Minimum lot size for residential use shall be no less than one acre. The maximum depth of any lots, exclusive of unusable land, shall not be more than 2 times the width of the lot at the minimum building setback line.

These regulations shall take effect upon adoption and publication as required by law.
