#### **Resolution # 2016-50**

#### RESOLUTION SETTING COMPENSATION FOR ABSENTEE ELECTION MANAGER

BE IT RESOLVED BY THE CITY COUNCIL OF VALLEY GRANDE, ALABAMA, AS FOLLOWS:

Section 1. Compensation for the Absentee Election Manager for the City of Valley Grande, shall be and the same is hereby fixed at the sum of \$50.00 per day for each day absentee elections services are performed from the date of delivery of the absentee ballots to the absentee election manager and including the day of the election, to be paid from the city treasury, including any and all days up to a run-off election if required, not to exceed 45 days.

Section 2. This resolution is adopted pursuant to Section 17-11-14 Code of Alabama, 1975, and shall be effective for all municipal elections, both general and special, held in the year 2016.

ADOPTED THIS THE 18th DAY OF JULY, 2016.

## Mayor's Report:

Mayor Labbe stated that he has had a lot of positive feedback from the community regarding the July  $4^{th}$  celebration.

He further reported that the sewer fencing project has started. The area around the lagoon has been bush hogged and the project is underway.

Mayor Labbe reminded everyone that July  $19^{th}$  is the last date to qualify as a candidate for the city council or mayor positions in the upcoming election.

Donna Downs stated Resolution 2016-48 should be repealed. She stated that it should have been on first reading due to it being a permanent operation. She stated that she had talked to the League of Municipalities and they said it was zoning and a council cannot do zoning. She stated that the Subdivision regulations only cover roads, drainage and water. She stated that zoning issues have to be done with a planning commission.

Mayor Labbe stated that Valley Grande does not have zoning. He showed a copy of the subdivision regulations and read a statement saying that the adoption of any amendment to the subdivision regulations shall be by resolution of the council with an affirmative vote of the majority of the city council. He stated that this was the way the subdivision regulations were adopted as an ordinance by the previous mayor and council and that is where the council stands. Mayor Labbe stated that will check with the league but until then the resolution stands.

There being no further business to come before the council, a motion to adjourn was made by Ronnie Sawyer. Tim White made the second. The motion was carried by unanimous consent of the council.
