# **Reports of Officers:**

<u>Boyd Pugh /Public Safety Director:</u> Boyd Pugh reported 7 fire calls so far during the month of November with one fatality and 2 calls for the month of December with 2 fatalities. He further reported that EMC was unable to launch the boat into the sewer lagoon. A backhoe may be needed to move the dirt from the bottom of the launch area.

<u>Sam Smitherman/Building Inspector</u>: Sam Smitherman reported 10 houses currently permitted with 4 about to be ready for final inspection.

<u>Tim White /Zoning, Annexation and Sewer System:</u> Tim White reported that he will try to have someone remove the dirt and allow the boat to be launched to treat the duckweed at the sewer lagoon.

<u>Ronald Sawyer / Beautification and Education:</u> Ronnie Sawyer reported that Teen Challenge has started the trash pick up on the roads through out the City.

<u>Lamar Morgan / Public Safety:</u> Lamar Morgan reported that construction of the new storage building is complete but needs slag to go around the building.

A motion was made by Lamar Morgan to order 2 loads of slag. One for the parking lot at the sports complex and the other to be spread around the storage building. Ronnie Sawyer made the second. Motion carried with unanimous consent of the council by a show of hands vote.
